WHEREAS, The Board of Trustees of the Village of Oblong, in the County of Crawford and the State of Illinois, did on the 6th day of July, 2016, pass the Annual Appropriation Bill for the Village for the fiscal year beginning the 1st day of May, 2016, and ending the 30th day of April, 2017, the amount ascertained to be the aggregate pamphlet form on the 6th day of July, 2016.

NOW THEREFORE:

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE CURRENT FISCAL YEAR:

BE IT ORDAINED By the Board of Trustees of the Village of Oblong, Illinois:

SECTION 1: That there be and is hereby levied upon all taxable property within the corporate limits of the Village of Oblong, Illinois, for general corporate purpose of said Village for the fiscal year beginning on the 1st day of May, 2016, the sum of
