

TAX LEVY ORDINANCE NO. 2023-O-642

WHEREAS, The Board of Trustees of the Village of Oblong, in the County of Crawford and the State of Illinois, did on the 3<sup>rd</sup> day of May, 2023, pass the Annual Appropriation Bill for the Village for the fiscal year beginning the 1<sup>st</sup> day of May, 2023, and ending the 30<sup>th</sup> day of April, 2024, the amount ascertained to be the aggregate pamphlet form on the 4<sup>th</sup> day of October, 2023.

NOW THEREFORE:

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE CURRENT FISCAL YEAR:

BE IT ORDAINED by the Board of Trustees of the Village of Oblong, Illinois:
