The undersigned, representing him/herself as owner or tenant of the property located at address below, hereby makes application for connection to the Water System of the Village for said property, and in consideration of the furnishing of said service covenants and agrees as follows:

- 1. I agree (*if applicable*) to pay a \$500.00 tap-on fee plus the cost of all necessary materials and including the cost of road boring if necessary and the cost of any permits or easements that may be required. I agree (*if applicable*) to pay a \$150.00 renter's deposit. I agree (*if applicable*) that if I am purchasing property from an owner on contract, that I will pay a \$150.00 deposit (refundable by presenting a copy of the sales receipt signed by the owner).
- 2. I agree to abide by all rules and regulations as specified in and by the ordinances of the Village now in effect or enacted and passed from time to time providing for the regulation of service furnished by the Village, it is further acknowledged and agreed that the undersigned, his heirs, executors, administrators, successors and assigns shall pay all charges for connection fees and water usage which shall become due as the result of the connecting of the water mains and the furnishing of water service to the above property, and that all such charges and fees for water service rendered to the property, together with penalties, if any, and the costs of collection are to be considered and become a charge against the property, the lien so created to be enforced in accordance with the ordinances of the Village.
- 3. All bills for the aforesaid charges are payable on or before the due date following the receipt of said bill and if not paid, are subject to a **ten percent (10%) penalty and termination of service. I understand that if my water service is terminated for non-payment, I will be charged a \$50.00 re-connect fee to have my service turned back on.**
- 4. Each and all of the agreements and covenants herein contained shall run with the real estate above described whose present owner is signatory to this application.
- 5. Permission is hereby granted to the Village and its authorized representatives at any reasonable time to enter the premises of the applicant and any portion thereof for the purposes of inspecting all connections appurtenant to the Water System.
